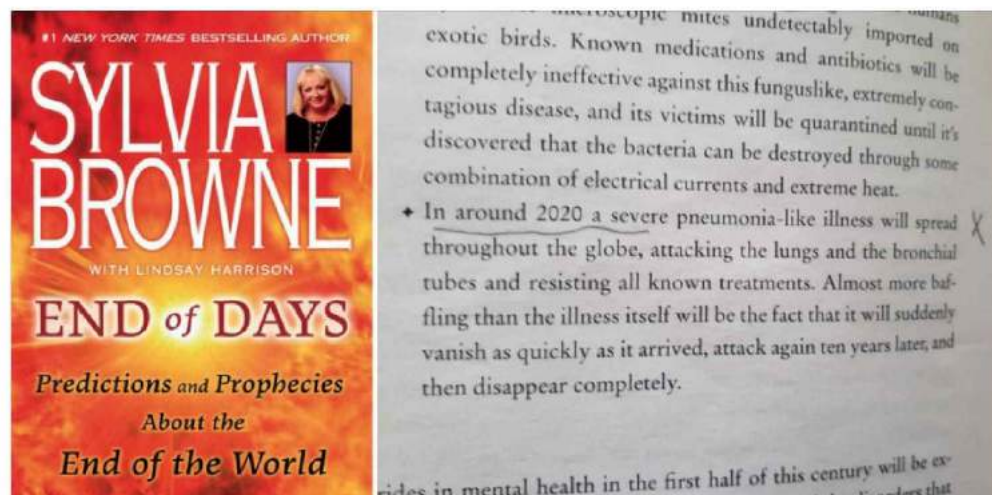

Farmers and hill-walkers

Madam, - Joe Walker's claim (January 28th) that a minority of hill-walkers are responsible for the rising level of conflict over countryside access is misinformed and misleading.

Mr Walker owns land in the Glencree Valley through which a short section of the old coach road to Dublin runs. This route, mapped by Jacob Neville in 1760, and referred to repeatedly since then in a variety of publications and shown on Ordnance Survey and Coillte maps, is important because it enables recreational walkers as well as locals to walk from Curtlestown to Kilmolin, where visitors often park or catch the bus, without risking life and limb on the main Glencree-Enniskerry road. It has been in use since time immemorial.

Mr Walker has planted trees across this roadway. On nine occasions over the last year, he has, on his own admission, erected fences - some of barbed wire - to block access to this long-established route. Locals and others have removed these obstacles.

For Mr Walker to suggest, as he did in his letter, that 95 per cent of hill-walkers would support his right to behave in this fashion is nonsense. Suffice it to say that the Irish Ramblers, An Óige, the Holiday Fellowship Walking Group, Na Coisithe - in short all of the main hill-walking groups - have made applications to Wicklow County Council for the old coach road to be secured as a right-of-way in the forthcoming County Development Plan. So, significantly, have a number of Mr Walker's neighbours.

The fact that the Mountaineering Council of Ireland is still twiddling its thumbs on this matter - and all other matters of rights-of-way - merely indicates how far behind its main constituent parts this ineffective body finds itself.

For Joe Walker to brand as extremists those of us who merely seek for Ireland the same rights as walkers enjoy in the rest of Europe is a fair indication of his mind-set.

The tragedy of the present impasse on the access issue is that no other pastime holds as much promise for bridging the rural-urban divide as hill-walking. - Yours, etc.,

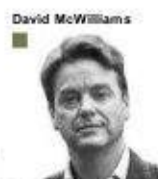

Various internet allegations can be found that indicate that Albert Smith worked on Andrew Dedman's generated data bases over a period of many years and that some of the data based files (The Dedman Files) were allegedly transferred secretly by Dedman himself to amongst other the Store street Garda station (against human rights treaties) as these files were held secretly in Ireland by "black" cops.

From an anti-fascist perspective Smith is obviously demonstrating his real motives and complete understanding as to the need and necessity for the purpose of, promotion of and the production of these "banned" books from the twisted minds of the higher order. While capitalist control of production rests ultimately on their control of political power (and its guns), it is also, sadly, the case that capitalist society is mainly kept going by the pro-capitalist ideas most people hold. As the anarcho-communist Alexander Berkman put it:

Quote:

Our social institutions are founded on certain ideas; as long as the latter are generally believed, the institutions built on them are safe. Government remains strong because people think political authority and legal compulsion necessary. Capitalism will continue as long as such an economic system is considered adequate and just.

This means that the most subversive of capitalism activity that socialists can engage in is undermining these ideas by constant criticism of them. Which is what we in the Socialist Party are doing. When a sufficient number have rejected capitalist ideas then capitalism's days are numbered, even if they do initially still have guns but a socialist majority can take these away from them by winning control of political power itself.

You are right that under capitalism democracy is distorted by all sorts of things, including the secret services and their activities. I'm not sure that "fascism" is the right word to describe this. A better term would be "authoritarianism" or something like that. After all, these practices existed before historical fascism. In fact the word "fascism" should probably be confined to the inter-war period in Central and Southern Europe.

"Wuhan-400 is a perfect weapon. It afflicts only human beings. No other living creature can carry it. And like syphilis, Wuhan-400 can't survive outside a living human body for longer than a minute, which means it can't permanently contaminate objects or entire places the way anthrax and other virulent microorganisms can. And when the host expires, the Wuhan-400 within him perishes a short while later, as soon as the temperature of the corpse drops below eighty-six degrees Fahrenheit. Do you see the advantage of all this?"

Tina was too busy with Danny to think about what Carl Dombey had said, but Elliot knew what the scientist meant. "If I understand you, the Chinese could use Wuhan-400 to wipe out a city or a country, and then there wouldn't be any need for them to conduct a tricky and expensive decontamination before they moved in and took over the conquered territory." Dombey said. "And Wuhan-400 has other, over most biological agents."

"Koontz" has apparently written many books under various pseudonyms. And so it was the case with *The Eyes of Darkness*, which was originally released in 1981 under the fake name of Leigh Nichols. Not only does this book mention a "bioweapon" from Wuhan, China, but on the very next page, also mentions the "ebola virus" from Africa.

Inside the secret state

Ever get the feeling you're being watched? That doesn't mean you're paranoid: discovered Alan McCombes when he met up with two former MI5 agents, Annie Machon and David Shayler, who have blown the lid on the British secret services. From sending agents to socialist organisations? meetings to funding an al Qaeda bombing campaign, they tell how British Intelligence operates at home and abroad, utterly unaccountable and with little regard for laws or lives.

A dossier used to justify the invasion of a foreign country so far-fetched it could have been written by JK Rowling. Fearsome weapons of mass destruction that turn out to be more elusive than Lord Lucan. The cold-blooded shooting of an innocent young man following a botched up surveillance operation that would have embarrassed Austin Powers. Among the general public, the credibility of the British intelligence services was already in meltdown even before Stormontgate. The revelations that the security services may have been involved in orchestrating a plot to bring down the elected Northern Ireland Assembly is unlikely to shock anyone who has read *Spies, Lies and Whistleblowers: MI5, MI6 and the Shayler Affair*.

This explosive book was written by ex-MI5 agent, Annie Machon, with the assistance of her partner, David Shayler. It ranks alongside Tony Bunyan's 1970s classic, *The Political Police in Britain*, as one of the most important exposures of the British intelligence services ever published. For 15 months, the *Spies, Lies and Whistleblowers* book was banned. The main publishing houses were then warned off touching it. Eventually a small publisher took it on. Even then, it was subjected to MI5 censorship, with chunks of text blacked out under orders from the faceless men and women who lurk in the undergrowth of the British state.

The book has been systematically ignored by most of the mainstream media - raising serious questions, it has to be said, about the influence of the British secret intelligence services within the newspaper industry. During a recent visit to Scotland, David Shayler and Annie Machon told the Voice the extraordinary story of how they became spies, then fugitives, then pariahs in the eyes of the British establishment. Along the way, David has fought court battles and served several prison sentences. Their long road to international notoriety began back in the days when Tony Blair was still a fresh-faced, backbench, opposition MP. When Shayler, a Dundee University graduate, spotted a job advert in the Sunday Times under the headline, 'Godot is Waiting,' he was intrigued. In Samuel Beckett's acclaimed play, *Waiting for Godot*, two tramps wait for a mysterious individual who never arrives and whose character is never revealed. Eventually, the organisation behind the Godot recruit advert did reveal itself - but only after several gruelling interviews, in which David was given the third degree about his politics and background. He admits he was shocked to discover the identity of his cloak-and-dagger prospective employer.

Shayler was an unlikely recruit for MI5. As a student he had participated in demonstrations and had been a member of Anti-Apartheid and CND. As the editor of the Dundee University student newspaper, he had even been served with an injunction after publishing extracts from *Spycatcher*, the banned autobiography of former MI5 officer, Peter Wright. Shayler admits that, by the time of his recruitment to MI5, his earlier radicalism had diminished: 'The miners strike had been defeated, then the printers at Wapping. Like a lot of people at that time, I had become disillusioned with left wing politics. But I still couldn't understand why MI5 would want to take an interest in someone with my background. Some of my friends were convinced I was winding them up about the whole thing. But to my surprise, I kept getting through each stage of the recruitment process and ended up in the service. Shayler had also been subjected to the highest level of security vetting. This involved Special Branch interrogating former friends and neighbours to build up a detailed picture of his character and behaviour. There was only one glitch. That was when MI5 discovered they held a personal file on one of Shayler's referees - a friend from student days who had come to the attention of the security services after attending a couple of SWP meetings.

The Kerryman may be a Joe, but he's not an Uncle Joe, and he regretted that under the rules of Leader's Questions, he didn't have time to "educate" the Taoiseach on his relations with "Stalinists". No Stalinesque figure has yet emerged from these turbulent events. But it was noticeable during Taoiseach's Questions that Willie O'Dea - a heavily moustachioed southerner who recently seized control of the Army - occupied the seat beside Mr Ahern, where Mary Harney usually sits. Yesterday also saw the first purge of the revolution, when independent TD Dr Jerry Cowley was sent into internal exile by the Ceann Comhairle. The Mayoman had objected too long after the Taoiseach called him a "right-wing doctor". The same compound adjective is suddenly popular in the Dáil. Defending Aer Lingus workers and expressing scepticism about privatisation, the Taoiseach snarled that he would not bow to some "right-wing economist." To be denounced as a right-wing anything by this revolutionary government could be the beginning of a trip to the salt-mines.

Irish Leader's Unexpected Embrace of Socialism Is Causing a Stir

After 10 years at the helm of Ireland's dominant political party, Prime Minister Bertie Ahern marked the occasion recently with a surprising revelation - a political coming out of sorts - that has had Ireland in a spin.

His declaration was as simple as it was unexpected: "I am one of the few socialists left in Irish politics," he said in an interview with The Irish Times on Nov. 13, shocking his colleagues, infuriating his opponents and bewildering the public into wondering what kind of leader it had elected.

Since 1997, Mr. Ahern's party, Fianna Fail, has led the Irish government in a tight-knit coalition with a small but vocally right-wing party, the Progressive Democrats, which has cracked down on immigrants and taken a pro-business stance to woo foreign investors. So in the debating chamber of the Irish Parliament last week, Mr. Ahern's rivals spluttered with indignation, demanding to know how a man who had presided over year after year of tax cuts could call himself a socialist.

"People mightn't believe this, but I have a very socialist view on life," he told The Irish Times. "What is the best form of equality? It is the fact that the richest family in this area can go on a Sunday afternoon to the Bots" - the national botanical gardens, which are in Mr. Ahern's Dublin district - "and the poorest family can, too." Columnists joked that "Comrade Ahern" had wrapped himself in a red flag that had been made-to-measure by a luxury tailor, and Irish Times letter writers responded, en masse, with incredulity. "A certain asceticism and a willingness to allow the masses to use public parks are not the tests of socialism," one wrote.

For history students in the Dáil yesterday, the echoes of Russia in 1917 were unmistakable.

Back then, it was an alliance of workers and soldiers, led by a charismatic socialist called Trotsky, that came together to overthrow the establishment. Now, led by a charismatic socialist called Bertie, soldiers (of destiny, in this case) again seemed to be making common cause with workers, while bosses everywhere quaked. The excitement was added to by the return from a trip abroad of Joe Higgins.. There were shades here of Lenin's return from Finland to address the Petrograd Soviet, except, of course, that Mr Higgins's thinking has historically been closer to Trotsky's than Lenin's. It has also been a lot closer to both than to Bertie's. But yesterday Mr Higgins seemed ready to join the Taoiseach in a revolutionary partnership. So before the November Revolution could proceed, he set Mr Ahern a test to see

The realization sank in quickly, however, that the announcement was anything but a throwaway line for Mr. Ahern, a well-liked and astute politician with his ear always - critics say too firmly - to the ground.

The statement seems to have had an immediate impact on his positions, as he sided with workers by criticizing the management of the state-owned airline, Aer Lingus, in Parliament on Wednesday.

Last summer, Fianna Fail (pronounced FEE-na foyle) suffered the worst electoral defeat in its history, losing seats in local and European legislatures to left-wing groups like Sinn Fein, the political arm of the Irish Republican Army that appeals to working-class voters with a mix of nationalism and grass-roots issues.

As a result, Fianna Fail - its name means Soldiers of Destiny in Gaelic - is softening its image and returning to blue-collar voters who were alienated by policies that are perceived as antilabor. "One's first reaction is to treat this outlandish claim with derision," said Joe Higgins, the Socialist Party's member of Parliament. "But anything that Bertie Ahern says is said with intent." "Socialism hasn't been flavor of the year for several years," Mr. Higgins said. "He knew that he would get a reaction." But even before Mr. Ahern revealed his enthusiasm for socialism, it was considered a legitimate and functional ideology here. Socialists won a handful of seats on local councils in June, and Mr. Higgins, one of the most respected orators in Parliament, gave impromptu lessons in Marxism on current affairs radio this week. Fianna Fail's policies under Mr. Ahern, however, "have been anything but traditionally socialist," said Brian Nolan, an economist with the Economic and Social Research Institute in Dublin. Income distribution in Ireland has always been highly unequal, and the gap between rich and poor grew during and after the boom years of the 1990's.

Taoiseach insists he is a socialist

A confidential report from December 1974 addresses the outlook for Dublin's presidency of the then European Community and notes "Ireland's insistence on staying out of military alliances, its long-standing Francophile biases, and its pragmatic determination to avoid contravening basic British interests".

It also rather sniffily details how "the country's most able diplomats were sent to the major European posts while J. Molloy, the non-political assistant secretary in charge of administration, was sent to Washington".

The CIA shrewdly thought of the practicalities - the difficulty of physical communication - with London being the only EC capital having frequent flights to Dublin.

"The Irish will have their hands full," it concluded.

Meanwhile, in a secret document dated March 6, 1975, the CIA turned its sights to the first threat of Brexit - the UK's referendum for the country's continued support of membership of the EC.

Negotiations between members at a meeting in Dublin "will undoubtedly be prolonged and is expected to have at least a show of cliff-hanging to enhance the chances for a favourable British vote in the pending referendum on EC membership later this year," the CIA surmised.

CIA thought the spoon-bender Uri Geller had some 'psychic powers'

CIA agents came across as slightly naive in files addressing the wonder of illusionist Uri Geller and his spoon-bending capabilities.

The CIA put Geller to the test in 1973, aided by scientists at the Stanford Research Institute.

Geller was locked in a shielded room and asked to recreate the same sketch as that drawn by an experimenter down the hall.

Geller failed several times but succeeded often enough to convince the CIA of his psychic powers.

"We consider that he has demonstrated his paranormal perceptual ability in a convincing and unambiguous manner," the CIA report concluded.

The agency eventually recognized Geller's tricks as the work of an illusionist.

Newspaper stories debunking Geller's claims are contained in the archive with a note saying "just in case you didn't happen to see this".

'UFO calls just dried up'

Flying saucers provided much food for thought for the CIA from the 1940s through to the early 1990s.

Most of the documents concern CIA cables reporting unsubstantiated UFO sightings in the foreign press.

A heavily redacted document said the US Forecast Centre had been "plagued" with calls about UFO sightings, which then stopped.

An unnamed individual had told the CIA that he "never gets these calls anymore and surmised that someone must have made a political decision that they were not to be sighted anymore".

Proper spy business is addressed in documents from the archive which give a German recipe for invisible ink.

Another paper tells how to open sealed letters with the application of many chemicals - and an iron.

Taoiseach Bertie Ahern is one of the few genuine socialists in the country, his former finance minister claimed today.

European Commissioner Charlie McCreevy said he believed the Taoiseach's controversial assertion of his political beliefs.

"Well Bertie pronouncing himself as a socialist wasn't a surprise to me because funny enough, I believe Bertie Ahern is one of the few socialists in Dáil Eireann, and would have said that many many years ago," he said.

There was genuine amazement in political circles when Mr Ahern made the pronouncement in a newspaper interview last year. It was widely seen as an attempt to reposition Fianna Fáil as a party for working class people in the face of Sinn Féin's growing popularity.

The writer and socialist Eamon McCann has said that if Bertie Ahern was a socialist, then "the moon is a balloon, Ian Paisley is a member of Opus Dei and Tony Blair never told a lie in his life".

But Mr McCreevy said that while it was not his job as European Internal Market and Services Commissioner to defend Bertie Ahern, he believed he was a genuine socialist.

"I would have said that many years ago. I said it around the cabinet table, I said it among friends when I wasn't on the airwaves and I believe it. He's one of the very few. I'm not by the way, as you're probably aware."

He told RTÉ radio that Socialist Party TD Joe Higgins was one of two other genuine socialists in the Dáil but declined the name the remaining politician.

Judge Cooke suggested that police in any English-speaking country would be familiar with the phrase "running informants off the books". But Callinan's use of it apparently still fuelled suspicion. Embarrassingly for GSOC, his remarks were wrongly cited in an internal report as the reason it launched the sweep of its offices.

Enter Verrimus, a London security firm staffed by retired British army officers; it conducted a preliminary sweep over five days last September.

It detected two threats. The inactive wireless device in GSOC's boardroom, which no one had the password to, was connecting itself to the wifi network in a local coffee shop. A conference call line in the chairman's office responded positively to a late-night intercept test by ringing.

Its report used language like "Red Flag Warnings", "multiple threat detected", "guaranteed threat" and "hostile attack", which may have "unduly alarmed" the three GSOC commissioners, according to Judge Cooke.

He suggested that it was "unfortunate" that they didn't get a second opinion before launching a public interest investigation, under Section 102(4) of the Act, on suspicion that gardai may be involved.

Verrimus returned to conduct more cover tests over an October weekend when the offices were empty.

Saturday produced nothing. Sunday was action-packed.

After the coffee shop downstairs with its free wifi opened, the wireless device in the boardroom became active. It seemed to be transferring data. One Verrimus operative told Judge Cooke: "I was told that the display that I was watching was a visualisation of data moving in and out of GSOC... and data was coming into GSOC via the same device."

His colleague checked out the coffee shop for users of mobiles or computers. He saw "an unknown male enter carrying a nylon sports bag" which appeared to contain a heavy, large "box-shaped item".

As they worked on the communications console in the boardroom they noticed people "making inordinate attempts to watch what we were doing from the street."

Meanwhile a GSOC officer noticed a white van parked in the street with a direct line of view straight into the GSOC board room. He went to investigate, and noted that the windows were blacked out. He walked around the block and two men walked by him twice. The third time, they saw him, turned and walked away.

At the same time, the Verrimus men discovered another anomaly when one of its iPhones identified a UK mobile phone network in the area. Verrimus later concluded it was a

"On the face of it, it would hardly be surprising if the Security Branch knowing that UK counter-surveillance experts were in Dublin with very sophisticated equipment had an interest in the identities of their other potential clients."

The intrigue does not end there. After the inquiry was announced, the lead Verrimus consultant got a phone call from a retired Irish army officer working in surveillance, anxious to pass on concerns from gardai and army.

He said: "Well, you know, one of the things that may come out of this, when you speak with the Judge ... Is to impress upon him that that particular aspect of things that actually that you would like the gardai would actually get a copy of everything, right."

In a second call, he said the "boys in green" were trying to "get a man in" on the inquiry who would "know what he was on about".

Afterwards, an ex-army intelligence officer of 20 years' experience wrote a letter to the Taoiseach offering his services to the Cooke inquiry. Judge Cooke passed.

There is even an intriguing postscript. GSOC officers found that, since all the brouhaha about bugging, the battery life of their mobile phones has mysteriously returned to normal.

Inside CID: The real reasons nobody wants to be a detective any more

To get into CID it used to be that you had to climb over dead bodies because it was the job everyone wanted," says detective Karen Stephens.

It is not - and never has been - a job for those who want to know when they will clock off, says Dave Tucker, a trained detective and crime lead at the College of Policing.

"If you are on a shift as a PC, when you finish you can go home whereas if you are a detective, you are required to stay on duty to complete your investigation. It makes your private life more difficult to manage because you don't know when you are going to get home," he says.

But at the same time there has been an increase in the number of "vulnerable" victims that detectives have to support in crime investigations, from domestic abuse to child sexual abuse, modern slavery and historic sexual offences.

"There's less armed robberies and more focus on safeguarding and the safety of people. If you get decisions wrong, the consequences can be more significant," says Mr Tucker.

With more high-profile cases to handle, detectives are also in the public spotlight where mistakes are picked apart. Take the latest controversy over the Operation Midland inquiry into the VIP child sex ring - or the Ted Heath inquiry. Go further back and there is Baby P or Victoria Climbié.

As well as the court of public opinion, there are also serious case reviews, homicide reviews and the Independent Office for Police Conduct, which investigates complaints.

"There is a sense on the part of some investigators that the complaints procedure is unfair and loaded against cops," says Mr Tucker. "From the inside it can feel like the dice are loaded against you."

Commander Karen Baxter, head of economic crime at the City of London Police, led some of the biggest terror and murder investigations in Northern Ireland in a 26-year career in the province.

"It wasn't a popular job to be a senior investigating officer of homicide, or terrorism because lots of people saw it as too risky. They can be very public roles and you can be subject to inquiries, to massive media interest," she says.

"There are a lot of people who don't want the risk. They don't want the publicity. They don't want what can be difficult circumstances placed upon them and their family. So there's a lot of people who simply do not want that intrusion on their lives."

Ms Stephens, however, has no regrets. She feels her detective roles were "probably my most rewarding jobs."

She says: "I still get excited when teams come up and say: 'We have a job, we're going to kick someone's door in next Thursday at six o'clock, or we've arrested this person, seized this amount or we've put a bad person in front of the courts.'

"I still love that but if you don't have that hunger, I think it's a hard job to maintain. I'm not sure there's the same hunger for all of those things in society. It's not trendy anymore. It used to be the trendy thing that you're a detective with all those TV shows."

The government appointed a high court judge to investigate the matter, and in June 2014, Judge John Cooke concluded that the available evidence did not support allegations that GSOC's offices had been bugged.

He also said it was even more unlikely that members of the police would be involved in unlawful surveillance.

The British security firm, Verintus, said it stood over its findings that it had identified "credible threats" during the surveillance sweep.

GSOC held its own investigation in a bid to find out how the confidential findings of the surveillance sweep had been leaked to the *Sunday Times*.

The barrister appointed to carry out the investigation was unable to identify the source of the leak.

When the barrister's report was published last September, Mr O'Brien said he had no intention of resigning as a result of the issue.

He said his office had learned lessons from the case and wanted to move on from it.

The letter from Benjamin A Gilman to William J Casey, director of the CIA, dated November 1982, was contained along with press reports of the trial in a cache of some 13 million pages of documents declassified by the CIA and released on its website.

The move came after lengthy efforts from freedom of information campaigners and a lawsuit against the CIA which culminated in the agency finally releasing the archive which had previously only been accessible at the National Archives in Maryland.

The area in and around the watchdog's inner-city office is festooned with CCTV cameras and the commission has its own system.

Nowhere in Judge Cooke's report was there any explanation of what actions GSOC took.

It is baffling that GSOC then launched a secret public-interest investigation and did not collect all the security footage in the area which it is empowered to do.

After all, the Commission regularly seizes footage from pubs where gardai were suspected of drinking on duty.

And then there is the glaring question that would spring to the mind of even the dumbest amateur.

Why did no one check the registration plate on the mysterious white van with the blacked out windows?

Perhaps rumbling journalistic sources is less daunting than unmasking shadowy spies.

Spy story with many twists but no neat ending

STROLLING around busy, seedy Capel Street or Abbey Street, most people wouldn't turn a hair at a white van with blacked-out windows parked on the street, or a guy sitting in a coffee shop with a lap top, or two men walking in circles around the block.

But if you're working for the Garda watchdog on a highly sensitive investigation into allegations that police allowed criminal touts to smuggle drugs in exchange for information, the cops are going nuts, the mobile phones are acting up and you've called in the spy catchers, you can see how these apparently innocuous encounters might take on a more sinister hue.

The Garda Síochána Ombudsman Commission (GSOC) was advised that these encounters were "possible indicators" of spies in their midst.

In his long-awaited report on the alleged Garda bugging scandal, published last week, the retired High Court judge John Cooke answered some questions but raised others.

He found no evidence of GSOC covert surveillance, least of all by gardai. He couldn't say with certainty that covert surveillance hadn't happened either.

In what he called the "febrile atmosphere of covert surveillance and counter-surveillance", it was extremely difficult to categorically prove.

However, one issue Judge Cooke did nail with certainty is the distrust at the heart of the affair. If the relationship between gardai and the watchdog wasn't so toxic in the first place, he suggested, GSOC might not have been so quick to set up a public interest investigation on suspicion that gardai were spying on them.

Like a good spy story, Judge Cooke's report reveals many twists but no neat ending.

It all started with the mobile phones. Specifically, the phones that two GSOC investigators used to call Garda crime and security branch about very sensitive investigations, one of which was coming to a conclusion in late 2012 and the first half of 2013 after four years and much recrimination.

Although not identified in the Cooke report, it involved Kieran Boylan, a drug trafficker who had charges dropped after it was disclosed that he was a Garda informant. GSOC had launched a public interest investigation in 2008.

As it wound up, the atmosphere in the office was tense and anxious, Judge Cooke was told. There were media leaks and rows with gardai who were refusing to give them information: "We'll tell you what you can get and when you can get it," one garda told GSOC.

Against this backdrop, two GSOC investigators noticed the battery power mysteriously draining from their phones. They usually charged them overnight and they were good for 24 hours. Now they ran flat in two hours.

The GSOC officers suspected they were being bugged. As Judge Cooke noted, one of the side-effects of having an "ambient listening" device trained on your mobile phone is a rapid depletion of the battery.

In July, Simon O'Brien, a retired London police commander and GSOC's relatively new chairman, met the Garda Commissioner, Martin Callinan. During the meeting, Callinan used a phrase along the lines of "running informants off the books". According to Judge Cooke, this "surprised" the GSOC camp. Just a few days earlier, GSOC had discussed using this very phrase in relation to one of its investigations, but had decided not to.

"fake" network created by an IMSI catcher – a surveillance device that can intercept and track mobiles.

There was more "intrigue" at Dublin Airport as the two Verrimus operatives waited for a flight to the UK. They had passed through security and taken a seat in the departures lounge when a man approached, stood in front of them and took a camera from his shoulder bag.

The Verrimus men turned away, but he snapped them as they turned back.

They had been "burned" – "trade craft" used by the "opposition" to let them know that their cover was blown.

Verrimus operatives were convinced some sort of surveillance had occurred. They returned in November, setting up an elaborately faked meeting designed to flush out the supposed "spies". It did not succeed.

Afterwards, Simon O'Brien wrote in his log: "This investigation is now closed. I need to think about reporting. This will be difficult, we have found nothing."

GSOC didn't tell Minister for Justice Alan Shatter about the public interest inquiry, as Judge Cooke said he was mandatorily obliged to do.

Instead, he put the closing report in his safe.

There it would have stayed until its contents mysteriously winged their way to the front-page scoop in the Sunday Times in February, which in turn prompted a Commission of Inquiry.

Judge Cooke criticised the Sunday Times for stating as fact that GSOC had been bugged, as neither he nor Verrimus had found hard evidence of it.

The wireless device could have been activated during repairs using the public factory setting password, and he was not convinced that it was transferring data.

The "fake" UK phone network was highly likely to have been a UK network provider that was doing tests in the area for a new 4G installation.

But the "ring back" on the conference call phone line was more difficult to explain, and he found it impossible to rule out covert surveillance.

As for the physical surveillance, Judge Cooke had suspicions of his own. He noted that while testing GSOC's offices in September, a Verrimus consultant took the opportunity to try and interest the Garda security division in training courses and spy ware.

GSOC: Simon O'Brien resigns as chairman of Irish police watchdog

Simon O'Brien's tenure as chair of the Garda Síochána Ombudsman Commission was marked by a high-profile controversy over unproven allegations that Dublin headquarters had been bugged.

The Irish police watchdog, the Garda Síochána Ombudsman Commission (GSOC), has confirmed that its chairman Simon O'Brien is to step down from his post.

It said Mr O'Brien is leaving to take up a role as chief executive of the UK's Pensions Ombudsman Service.

His resignation takes effect on 30 January.

Mr O'Brien led GSOC for three years and during his tenure the commission was the focus of a high-profile controversy over claims the office had been bugged.

The allegations were not proved, following a judge-led investigation.

In his resignation statement, Mr O'Brien said: "I have been in Ireland for five years in two posts. This is a significant opportunity and I am looking forward to the new challenge."

"The new post will bring me back home to be with my wife and young family in London."

GSOC was established by the Irish government in 2007 to provide independent oversight of policing in Ireland.

Its main role is to investigate complaints about police officers' conduct.

'Electronic surveillance'

The bugging claims first emerged in the Sunday Times in February 2013, when the paper reported that a hi-tech surveillance operation had been uncovered at GSOC's Dublin headquarters some months earlier.

GSOC had called in a British security consultancy in 2012 to check its offices for bugs, and the firm found "three electronic anomalies" that could not be explained.

The firm's findings suggested evidence of electronic surveillance in a meeting room and a compromised wi-fi system.

The newspaper report caused widespread controversy, with concerns raised over who would have reason to spy on the body that held Irish police officers to account.

GSOC had not informed either the police or the justice minister about the findings of the security operation, and the minister publicly criticised Mr O'Brien for failing to do so.

Spies and journalists: the impossible relationship

The secret services of the most western countries have significantly grown in the recent decades, and journalists – and the citizens of these countries – face serious difficulties in finding out what they are doing. This was the core argument of the long-standing Financial Times journalist John Lloyd, who is also a Senior Research Fellow at the Reuters Institute. For the last six to twelve months, John Lloyd has been working on a book about the subject, in which he focuses on the growth of the secret services in France, the UK and the USA. According to Lloyd, these three countries have traditionally had powerful secret services. "France was the first country to form a spy centre. In the US, nearly a million people work with confidential documents. There are about 70 offices all over the country, which belong to the secret services. Also in the UK they have been large", Lloyd said. The Charlie Hebdo tragedy in 2015 has increased the investment in the French secret services. The budgets of the secret services are nowadays more public, Lloyd pointed out, at least in terms of the known total sum of tax money spent on them. But what the secret services are doing exactly, stays secret. "It is this impossible relationship between spies and journalists, that the nature of the secret services is secret. The secret services are a problem to journalists and will remain so. In democratic countries, the openness ends more or less at the door – if you know where the door is – of a secret service." In his talk, Lloyd concentrated on two examples of individuals who have brought classified information into the public domain. Wikileaks, the digital information leak platform founded by Julian Assange, was exposing some severe wrongdoings by several countries, including the US, in the first decade of the 2000s. The other individual who has become globally famous by leaking confidential information in 2013 is Edward Snowden. "The basic argument behind everything is, that the UK and US have bulks of data about their own citizens. They have secrets, which they want to hide from the audience. Most journalists agree on this, that there is some information which needs to be hidden. But where are the limits?" Lloyd asked. Lloyd stated that journalists should be able to examine even retrospectively, what the national secret services have done. In the US, journalists' interest in the secret services such as the CIA grew after the Iraq War. "The journalists' experience was that they were misled about the reasons for the war. They believed too much what the state was telling them, and now they feel professional shame. US journalists nowadays pay more attention than before to the CIA, and for example the torture claims", said Lloyd. According to Lloyd, in France the journalists don't trust the secret service. In the UK, the existence of the secret service MI6 has been widely known, but the issue has been surrounded by silence. "In the UK, you just

would not speak about it. Never. The budgets of the secret service were secret. If you worked for the MI6, it had to be hidden." What can be done about improving the secret services public image? The answer is to increase openness, suggested Lloyd. He pointed out that the secret services in the US and in the UK have already changed much: "The openness and transparency have increased, especially when it comes to their budgets. Also good public relations, PR, is important to the secret services. They should do more to keep improving their relationship with the press." Also, John Lloyd sees that the secret services should be monitored. There should be some kind of surveillance authored civil servant or "ombudsman", as he proposed, who would supervise the secret service and report the findings regularly, for example once a year. "The most important question is: how can we maintain trust? The trust between the states and their citizens, and the trust between the secret services and journalists," he asked.

John Lloyd, Senior Research Fellow at the Reuters Institute for the Study of Journalism spoke at the Business and Practice of Journalism seminar at Green Templeton College on Wednesday 9 March 2016.

Rush to vilify GSOC over bugging fears augurs badly

The most disturbing aspect of what happened after the *Sunday Times* claimed that the offices of the Garda Síochána Ombudsman Commission (GSOC) had been bugged, was the alacrity with which senior Government figures sought to consign the story to the rubbish bin.

Within hours, a well-sourced report in a respected newspaper was being turned on its head by the Taoiseach and Minister for Justice.

Síochána Act, to put in place an effective system of independent oversight, on behalf of the Oireachtas and the people, of the work of the national police force.

The guards have not liked it from the beginning. That is hardly surprising after a 200-year tradition in which a centralised police force answered only to government.

So it is up to government to make it clear to the police that accountability means what it says, that when GSOC asks for information it is entitled to get it swiftly and fully and that there must be no holding back or stonewalling. I am not aware that any such message has been delivered by the Government to the management of the Garda Síochána.

Heavy Gang

Yes, there is a problem within GSOC in that someone leaked the story to the *Sunday Times*. Yet I cannot help but recall the Heavy Gang scandals and finger prints scandal of the 1970s, when

Garda sources revealed systemic abuses that were reported in *The Irish Times*.

Would anyone now seriously argue that the greater good – including the good of honest, decent members of An Garda Síochána – was not best served by revealing these abuses?

The reality is that the 2005 Act is deeply flawed and must be revisited. It has created lacunae and it entrenches operational shortcomings that are not in the interests of the oversight body, the Garda Síochána or the public for whom they work. They only serve the interests of politicians who can navigate to their advantage within the ambiguities that have been created.

Writing last week, I noted that Alan Shatter had agreed to allow access by Gsoc to the Garda Pulse system in the investigation into the penalty-points controversy.

The Minister's media department has pointed out that he told the Dáil that where Pulse information is "of central relevance"

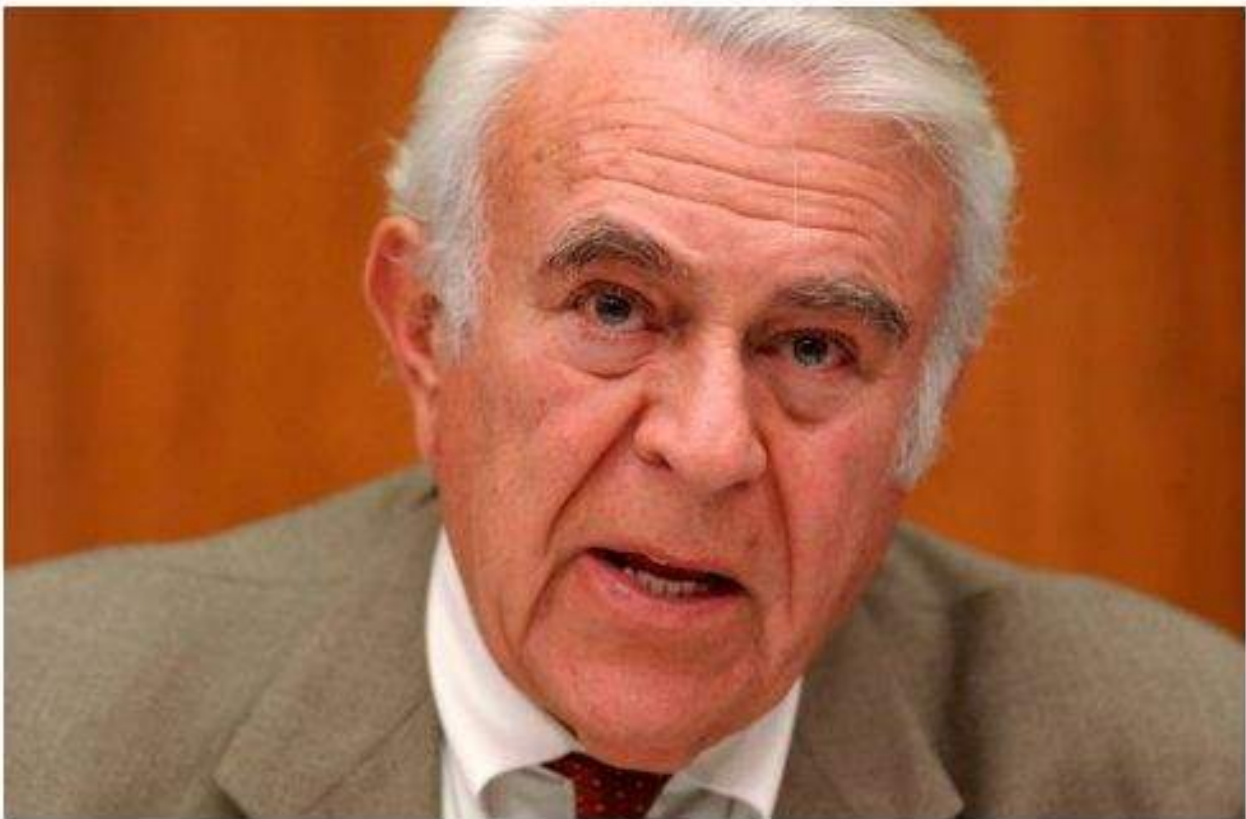

It followed the November 1982 trial of five self-confessed IRA gun smugglers - including Michael Flannery, the 80-year-old founder of Noraid - found not guilty of transporting an arsenal of weapons and ammunition into Northern Ireland.

The five claimed they bought the arms from an arms dealer who was an undercover CIA agent.

Denis O'Brien: a complicated career and dubious ethics

Denis O'Brien is one of Ireland's leading entrepreneurs with investments in international telecoms, radio, media, property, aircraft leasing, golf and other leisure interests. He founded the Esat Telecom Group plc and built it throughout the 1990s until its sale to British Telecom plc for €2.4 billion. He became a Portuguese resident and avoided £55m in taxes otherwise due. He also founded Communicorp Group which he owns outright to manage a portfolio of media and broadcasting-related companies in Ireland and eight other European countries. These include 98FM, Newstalk, Today FM, Highland Radio, Spin 1038 and Spin South West. He has a €600m stake (around 22%) in INM which owns the Evening Herald, Irish Independent, Sunday Independent, Sunday World and the Irish Daily Star, as well as 14 regional titles, two free newspapers, and a magazine.

He founded Digicel in 2001 when the company launched a GSM cellular phone service in the Caribbean. Digicel has extended its operations to 32 markets with over 11 million subscribers in the Caribbean, Central America and Pacific regions. In the year to March 2011, revenues at Digicel were up 27% to \$2.23bn. In 2010 O'Brien netted \$693 million from the sale of his Digicel Pacific Limited (DPL) business to the Digicel group.

In 2005, O'Brien became Deputy Governor of the revered Bank of Ireland. Simultaneously, he moved his residence from Portugal to Malta, for tax avoidance reasons. He resigned from the position of Deputy Governor Bank of Ireland, and also as a member of the Bank's 'court', in 2006. O'Brien also resigned from the Norkom Group and from the UCD Smurfit School of Business. O'Brien is a member of the Bilderberg group.

O'Brien part-funded the wages of Irish soccer manager, Giovanni Trapattoni. He is Chairman of the Ernst & Young Entrepreneur of the Year Judging Panel, having previously been a recipient of the award. In 2010, he was named Goodwill Ambassador for the city of Port-au-Prince in recognition of his efforts to rebuild Haiti and attract foreign direct investment. The Guardian recently ran a piece headlined "How an Irish telecoms tycoon became earthquake-devastated Haiti's only hope of salvation", which detailed how Port au Prince's iconic Iron Market will shortly reopen "all down to Denis O'Brien".

He is the Chairman and Co-Founder of Frontline, the International Foundation for the Protection of Human Rights Defenders which "works to ensure that the standards set out in the UN Declaration on Human Rights Defenders, adopted in 1998, are known, respected and adhered to worldwide".

In 2000, Denis O'Brien established The Iris O'Brien Foundation, named after his mother, to identify and assist projects in Ireland and internationally which aim to alleviate disadvantaged communities. The foundation has broad aims, including promoting human rights, helping people affected by disasters, helping people with a mental or physical handicap, advancing education and supporting the arts. The foundation has spent nearly €15.4m on charitable works.

O'Brien has links with Unicef, the Special Olympics, and Camara, which sends computers to developing countries. He has also funded multicultural awards and awards run by Social Entrepreneurs Ireland. He serves on the US Board of Concern Worldwide. He once donated £250,000 he had been awarded in libel damages to Amnesty International for which he sometimes hosts (not always uncontroversial) lunches. He was Chairman of the 2003 Special Olympics World Summer Games when the games were held in Ireland. In 2011, he provided money for the Presidential campaign of Mary Davis who had been CEO of the Special Olympics at that time.

He has an honorary doctorate from UCD and is a mate of former US President, Bill Clinton. Indeed, he flew him to the recent Dublin Castle beano in his jet, and later paid the tab for a late-nighter in the Unicorn restaurant with Clinton, the strangely ever-present Séamus Heaney and 22 others. If you mention your charitable cause to Denis O'Brien he is likely to give you his personal phone number. In short he is a dynamic and successful businessman and a hero to charities. Presumably on the back of this, he was a high-profile guest at events for Queen Elizabeth II, with whom he was oft-photographed earlier this year and at the two Irish Global Economic Forum conferences, whose invitees were suggested by the Department of Foreign Affairs (though this did not stop some protestations from Éamon Gilmore's Labour Party), held in the last year or so.

Last March, a judicial tribunal found that a former minister for communications, Michael Lowry, "secured the winning" of the 1995 mobile phone licence competition for Denis O'Brien's Esat Digifone. The tribunal also found that O'Brien made two payments to Lowry, in 1996 and 1999, totalling approximately £500,000, and supported a loan of Stg£420,000 given to Lowry in 1999. In his 2,348-page report, Mr Justice Michael Moriarty found that the payments from O'Brien were "demonstrably referable to the acts and conduct of Mr Lowry" during the licence process, acts which benefited Esat Digifone. In effect O'Brien was trading in influence or 'legal corruption'.

His former mate, Barry Maloney, absented himself from the recent Irish Global Economic Forum, writing

to the Taoiseach and Tánaiste informing them that he could not attend the event because Mr O'Brien would be a participant, despite the criticisms of him made in the final report from the Moriarty Tribunal. Maloney had given evidence to the tribunal that in 1996 he had a discussion while jogging with O'Brien concerning payments that Maloney, as chief executive of Esat Digifone, was obliged to sanction. O'Brien remarked that he himself had to make two payments of £100,000, one of which was to then Fine Gael minister, now Independent TD, Michael Lowry. This, he said, was a joke.

What was not a joke, however, was the termination of Sam Smyth's contract with O'Brien-owned Today FM. Smyth was the best-informed commentator on the Moriarty Tribunal and drew legal proceedings from both Lowry and O'Brien for his troubles.

The point, for these purposes, about Denis O'Brien is that, if you believe that not paying taxes and not paying money to Ministers to get favourable decisions on multi-billion-Euro deals, is unethical, then much of his money is not morally his. It is too easy to garner plaudits for philanthropy on the back of donations of cash, some of which is not ethically yours to give. This country has been brought to its knees by a treasonous golden business circle of which O'Brien is a member. But try telling that to the people who send out invitations on behalf of Enda Kenny, the Taoiseach.

It is more than a little ironic that this is the same organisation which created a crisis in the justice system two years ago on a claim, later found to be groundless, that it was the victim of a spy plot of which John le Carré would be proud.

But the drama ended in ignominy for the watchdog as the controversy descended into farce and the plot turned out to be more Austin Powers than James Bond.

But more of that later.

It has now been established that while some GSOC officials were leaking the bugging yarn to the media, some of their colleagues were simultaneously snooping – quite legally – on journalists' phone records to uncover the source of ... garda leaks.

You couldn't make it up.

It would almost be funny if it was not such a serious attack on press freedom – and hypocritical.

We can now reasonably assume that the garda watchdog has been systematically accessing the phone records of journalists suspected of receiving information from gardai, and not just those of the three we know of so far – Conor Feehan of Independent News and Media and the Irish Daily Mail's Ali Bracken and Senan Molony.

An immediate question is what is GSOC doing with all this sensitive information?

The plot thickened yesterday when the Irish Independent revealed that the private phone records of up to 50 individuals, who have no connection to either gardai or media, may also have featured in an investigation of alleged leaks around the arrest of Independent TD Clare Daly in January 2013 – a few weeks before the non-bugging scandal broke in the Sunday Times.

GSOC accessed the phone records of Senan Molony, the Mail's political editor, and after cross-checking the registration details of those he had been in contact with, found the number of a serving garda detective.

They then pulled the garda's records along with those of his wife.

The dogged inquisitors closely scrutinised the data and identified two other serving gardai he had been in communication with around the time of the Daly arrest.

That would have entailed a painstaking trawl through the registration details of the individual owners of all the phones in contact with the garda.

On paper it must have seemed like they had their man.

Only in July last year when he was summoned to a meeting with GSOC did the garda first realise he had been under criminal investigation.

And this is where it descended into farce for the garda watchers.

It transpired that their number one suspect coaches children in his spare time at a local rugby club and was in regular contact with up to 50 parents – including Mr Molony whose child is a member of the club.

For several months GSOC has refused to answer queries from the political journalist.

But following the recent revelations it appears they will be in receipt of many more awkward questions from the unwitting parents who became bit-players in this comedy of errors.

The sombre-toned report into the GSOC bugging controversy by High Court Judge John Cooke, in

which he concluded there had been no bugging, is unlike any other such document; it makes for riveting reading.

Despite its dispassionate legalistic language, the descriptions it contains are redolent of a Keystone Cops remake. In a bid to lure potential spies out into the open the judge recalled how GSOC officials and their English security consultants, Verrimus, set up a bizarre James Bond-style sting operation in October 2013.

An internal report was compiled in a document containing deliberately false and misleading information which would have been of major interest to any suspected eavesdroppers.

It was uploaded onto the GSOC computer system which Verrimus claimed had been subjected to cyber surveillance.

According to the Cooke report the bogus document stated that serious "errors" had been made in a previous report on a high-profile GSOC investigation.

The second part of the cloak-and-dagger ruse involved a meeting to "discuss" the false report as if it were true, in the office of the then GSOC chairman Simon O'Brien on the morning of Tuesday, November 19, 2012.

It was attended by the GSOC officers involved in the particular case and two of the commissioners, Carmel Foley and Kieran Fitzgerald.

Simon O'Brien, who was at home in the UK at the time, participated via a conference call using the audio/visual conference system in his office which Verrimus believed was also being secretly monitored.

One can only imagine what happened during the hour-long meeting as the GSOC officials acted out their roles for the benefit of the shadowy spooks lurking in cyberspace.

According to the Cooke Report, GSOC officers and their security consultants were on standby poised to "carry out arrests in the event that the surveillance was discovered".

But nothing happened.

The report also questioned a claim by Verrimus operatives and GSOC staff that a number of men were spotted carrying out surveillance on the GSOC offices.

On that occasion the specialists noticed that the watchdog's wi-fi system had connected - quite normally it later transpired - with the Bit buzz network in a *Insomnia* coffee shop on the ground floor of the same building.

When one of the operatives went to the shop he saw one person using a "handheld computer or mobile device".

A "white van" with blacked out windows was also spotted parked in the street with a direct line of sight on the offices.

The intrigue deepened further when two men were also supposedly spotted acting suspiciously close to the van.

And in Dublin Airport the English security experts claimed they were photographed by an individual who had them under surveillance.

But the most perplexing aspect of this tense drama is that it appears no effort was made by GSOC to uncover the identity of their spies.

The Taoiseach's reaction was particularly disquieting and surely indicative. One might have expected an expression of concern at an allegation that at least potentially strikes at the heart of the State's regulatory institutions.

Instead we had a castigation of GSOC for not reporting to the Minister for Justice, as, he claimed (erroneously) they had a duty to do under section 80 of the Garda Síochána Act.

Proprietorial

It is almost irrelevant at this time that the Taoiseach misunderstood or misquoted the law in relation to the Garda supervisory body. It was the proprietorial, almost dictatorial tone in which he delivered himself that told much.

GSOC had to "level with the Minister" and to account for its shortcomings. It had failed in its legal duty. The Taoiseach seemed to have no understanding that GSOC is not answerable to Government (in the same way as the Garda Commissioner) but to the Houses of the Oireachtas.

Chairman of GSOC, former London Metropolitan Police officer Simon O'Brien, did little to reinforce the independence of his organisation by expressing "regret" to the Minister (where he had no need to do so) and emphasising the "kindness" of the Garda commissioner in having a pot of coffee with him later in the week.

Honesty

Let us put aside for a moment the arcane arguments about "anomalies", "potential threats" and "vulnerabilities". GSOC commissioner Kieran FitzGerald spoke with clarity and shining honesty when he told the Oireachtas committee that the likelihood of a benign interpretation of the sweep by UK consultants Verrimus was "close to zero."

There can be little doubt that somebody bugged, or tried to bug, key offices of GSOC. And they knew their stuff. They went for the fourth floor, where commissioners and senior

staff meet for discussion and planning. Rank-and- file GSOC staff have no access to that fourth floor.

So who are the suspects?

Ordinary criminals? Subversives? Media? Foreign intelligence services – MI6 or CIA? A rogue element within GSOC itself? Gardaí who themselves (or their colleagues) may be under investigation by GSOC?

It is unlikely that ordinary criminals or subversives would have either the interest or the capacity to bug GSOC. From its establishment, GSOC has had in place relatively sophisticated counter-surveillance measures (on the advice of consultants that included former senior gardaí).

Thus, members of An Garda Síochána must, at the very least, be potential suspects in any investigation that begins on the premise that an attempt has been made to penetrate GSOC security.

Commissioner Martin Callinan has stated that no Garda surveillance, authorised or otherwise, was in place. With the greatest respect, it is doubtful if the commissioner knows everything that goes on in his force of more than 13,000 officers, as not a few of his predecessors in office found out to their cost over the years.

But it is the rush by Kenny and Shatter to rubbish GSOC's fears of having been bugged that is so disturbing. And it is consistent with a pattern since the establishment of the watchdog in 2005, to limit its capacities, and of apparent efforts to slow the pace and the effectiveness of its operations. This has been particularly evident since the GSOC inquiries into the alleged collusion between some gardaí and drugs importer Kieran Boylan.

Roll back

What we are witnessing here is an intuitive effort by the State – by the political establishment– to roll back the declared objective of the ombudsman sections of the 2005 Garda
